

Henry County Alumnae Chapter Scholarship Terms and Conditions

Terms and Conditions

This document outlines the Terms and Conditions for all scholarships, bursaries and awards, administered by the Henry County Alumnae Chapter of Delta Sigma Theta Sorority, Inc. All scholarships, bursaries and awards will be referred to as 'scholarships' herein. By submitting an application for our scholarship, you are agreeing to these terms and conditions.

You must read these Terms and Conditions in their entirety before you accept your scholarship offer. When you accept your scholarship you are agreeing to and accepting these Terms and Conditions and agree to the requirements and conditions of your scholarship.

Students in receipt of scholarship will be required to sign an individual scholarship agreement form. Students must meet all conditions as outlined in the agreement.

All correspondence between applicant and Henry County Alumnae Chapter will be operated primarily via email, with the option of telephone communication. All applicants must provide an email address to be eligible. Any changes to this email address, after submission of application and without necessary cause, may result in cancelation of their application.

Any successful applicant may be required to show proof that they are enrolled in an accredited university course, commencing studies for the fall semester 2019.

All students offered scholarships will receive an official 'offer' offering the funds, and must reply either accepting or rejecting this offer within 30 days of receipt.

Failure to respond within this 30-day period may result in the scholarship offer being withdrawn and reassigned. You must accept your scholarship offer by the due date, as instructed in your offer email, to be eligible to receive payment.

Henry County Alumnae Chapter will make payment of the funds in one single installment, though we reserve the right to make payment in multiple installments, as we see fit.

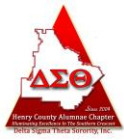
The total value of the scholarship offered will be outlined in the official offer email. We reserve the right to offer any value of funds, up to the value of \$1000 or the amount in the offer letter.

The scholarship funds can be paid into your school account, or mailed to the candidate personally, to be discussed between Henry County Alumnae Chapter and you the applicant. Henry County Alumnae Chapter reserves the right to make final decision on how payment is

made, and can withdraw the offer of scholarship if an amicable and realistic payment process cannot be reached.

Scholarships are awarded based on established eligibility criteria. You must meet the eligibility requirements to receive your scholarship payment. The eligibility requirements for each scholarship are outlined on our scholarship page of our website.

You may be permitted to hold more than one scholarship.

Henry County Alumnae Chapter is not responsible for and cannot provide you with financial advice on taxation matters. The information provided here is of a general nature only and does not take into account your individual financial circumstances. If you are enrolled full-time (at least 18 credit points per semester), your scholarship payment may not be taxed, however Henry County Alumnae Chapter is not responsible for checking and notifying you of, nor paying any taxation obligations.

Providing false or misleading information is an offence. If Henry County Alumnae Chapter knows or has reason to believe that you have provided false or misleading information, Henry County Alumnae Chapter may reassess your entitlement to the scholarship and you will be liable to re-pay to Henry County Alumnae Chapter the total sum of any payments incorrectly made to you.

Henry County Alumnae Chapter reserves the right to cancel the Scholarship program at any point.
